# **Description and Purpose:**

This Product Change Notification is intended to increase capacity for onsemi automotive MV7 MOSFET technology products by transferring wafer fabrication for these products to the Global Foundries Fab located in New York, US.

The changes include transferring wafer fabrication, back grind and back metal, to Global Foundries, and utilizing 300mm instead of 200mm diameter wafers. And while the assembly location remains unchanged, wafer saw and die attach tooling are being updated to accommodate 300mm wafers.
