

Figure 3. Load Circuit and Voltage Waveforms



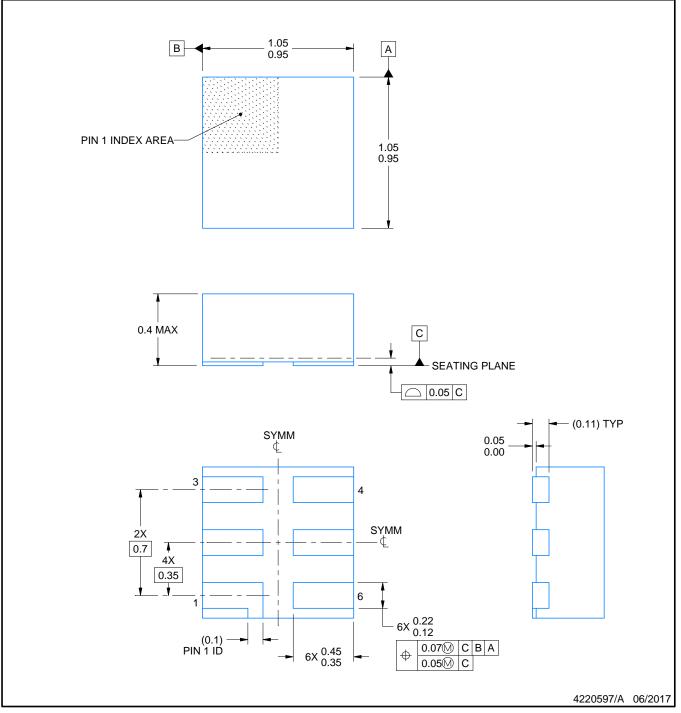

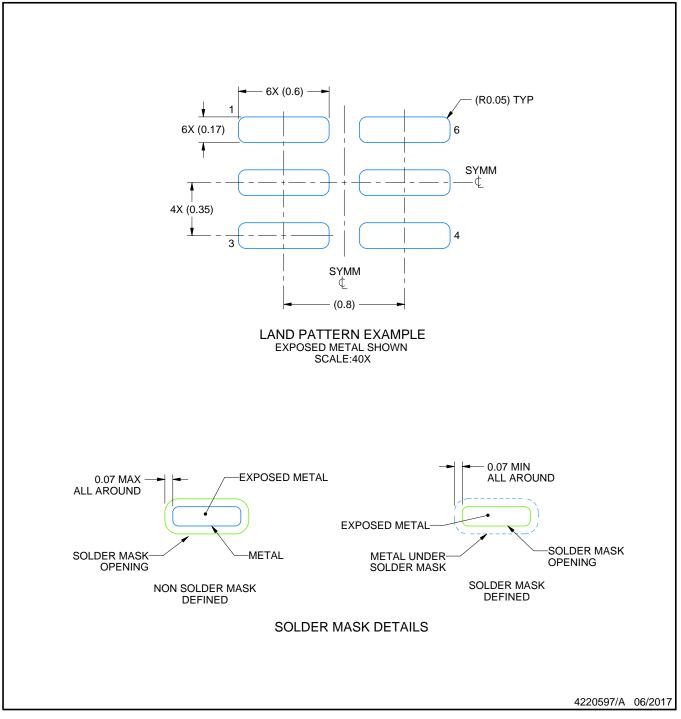
