


Figure 1. Test Circuit for $V_Z = V_{I(ref)}$




Figure 2. Test Circuit for $V_Z > V_{I(ref)}$






Figure 5. Shunt Regulator




Figure 6. Series Regulator




Figure 7. Current Limiter





Figure 9. Higher-Current Applications

Figure 8. Output Control of a 3-Terminal **Fixed Regulator**




Figure 10. Crowbar




Figure 11. V_{CC} Monitor
