### **Description of Changes:**

Cypress announces the qualification of SMIC Fab B2 Beijing as an additional wafer fab site for IoT devices 43432PMA0EA, 43433SMA0EA and 43143HB0DA. This qualification is part of the flexible manufacturing initiative which allows Cypress to meet its delivery commitments in dynamic, changing market conditions.

### Benefit of Change:

Cypress will have the added capability to meet upside market demand, ensure consistent and reliable delivery to customers.

### **Qualification Status:**

SMIC Fab B2 Beijing has been qualified for these IoT devices through a standard series of reliability tests.

### **Approximate Implementation Date:**

This change will be implemented 30 days from the date of this notification. Effective 30 days from the date of this notification, all shipments of the affected part numbers will be **fabricated** at either **new** or **original wafer fab site**.

### Anticipated Impact:

Products manufactured at SMIC Fab B2 Beijing site are completely compatible with existing product from a functional, parametric, and quality performance perspective.

Cypress recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

# Method of Identification:

There will be no changes to the part number. Cypress maintains traceability of product to wafer level, including wafer fabrication location and assembly location, through the lot number marked on the package. There will be no changes to the ordering codes or marking on production material after the change implementation date.
