#### **DESCRIPTION AND PURPOSE:**

This is a Final Process Change Notification to announce about the transfer of products from ON Semiconductor wafer fabrication sites located in Gifu Japan to the wafer fabrication ON Semiconductor Niigata Co., Ltd. (OSNC). OSNC which is located in Niigata, Japan, obtained ISO9001 certification.
