### Description of Change:

Cypress is planning to qualify new sources of supply for select RAM products currently running at JCET (78 Changshan Rd, Jiangyin, Jiangsu, China 214400) and OSET (12-2 Nei Huan South Rd. N.E.P.Z. Kaohsiung, Taiwan 811, R.O.C.).

The products will be qualified at the following sites already utilized by Cypress for similar packages:

- a. Greatek Taiwan for Assembly, Test, and Finish (No.136, Gon-Yi Rd. Zhunan Township, Miaoli County 350 Taiwan, R.O.C.)
- b. UTAC Thailand for Assembly, Test, and Finish (237 Lasalle Road, Sukhumvit 105 Bangna, Bangkok 10260 Thailand)
- c. Unimos China for Assembly (9688 Songze Ave., Qingpu Industrial Zone, Shanghai, China)
- d. KYEC Taiwan for Test and Finish (No. 81, Sec.2, Gongdaowu Rd., Hsin-Chu 300, Taiwan, R.O.C.)
- e. Cypress Philippines for Assembly, Test, and Finish (Gateway Business Park, SEPZA, Brgy., Javalera, General Trias, Cavite, Philippines)
- f. Cypress Bangkok for Assembly, Test, and Finish (229 Moo 4 Changwattana Road, Bangkok, Thailand)

These sites are qualified to build standard and automotive grade products consistent with AEC-Q100/AEC-Q006 standards.
