







PLASTIC QUAD FLATPACK - NO LEAD

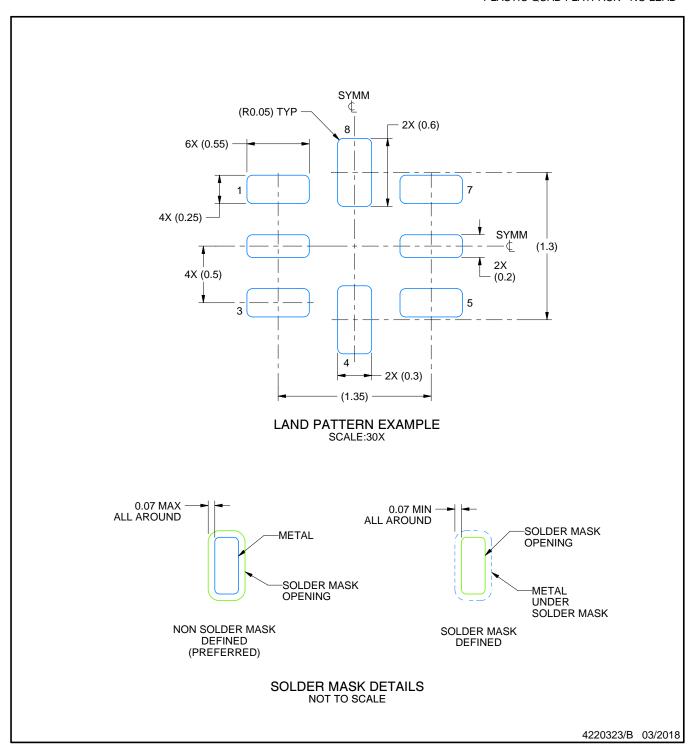

PLASTIC QUAD FLATPACK - NO LEAD

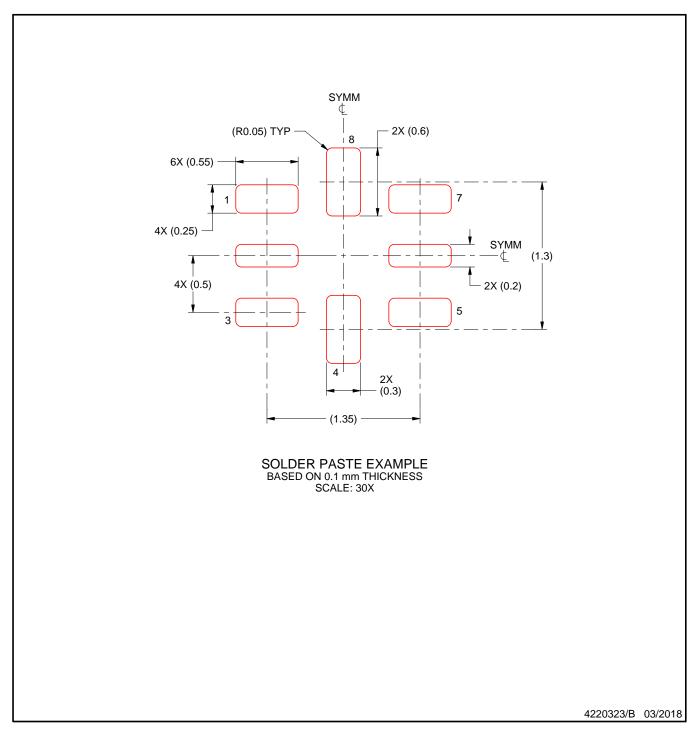
